Description of Necessary Measures

Inhalation

If frostbite or freezing occur, immediately flush with plenty of lukewarm water (100-105 F, 38-41 C). DO NOT USE HOT WATER. If warm water is not available, gently wrap affected parts in blankets. Get immediate medical attention.

Eyes

Flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Then get immediate medical attention.
